



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, July 25-27, 2024, naming the International Fresh Produce Association (1500 Casho Mill Rd. Newark, DE 19711) as the certificate holder. The following must be listed as additional insured: International Fresh Produce Association, Monterey Conference Center and Portola Hotel & Spa.

Rainprotection Insurance Program
