



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, naming the International Fresh Produce Association (1500 Casho Mill Rd. Newark, DE 19711) as the certificate holder. The following must be listed as additional insured: International Fresh Produce Association, Aramark, Anaheim Convention Center and the city of Anaheim and GES.

Rainprotection Insurance Program
